Payments: The schedule for payments begins at the time of registration. Additional payments are due June 1, 2010, July 1, 2010, August 1, 2010, September 1, 2010, October 1, 2010, November 1, 2010, December 1, 2010, February 1, 2011, March 1, 2011, April 1, 2011, and May 1, 2011. The payment schedule is for 12 equal payments. Full payment may be made at any time. Those registering after the payment plan begins may be placed on a mutually agreeable payment plan. All plans must be completed by May 1, 2011.

Terms: Payment is due the 1st of each month and is considered late after the 10th. A late fee of \$25.00 will be charged to your account if payment is received after the 10th of the month. A \$30.00 fee will be charged to your account for a returned check. No grades or transcripts shall be released for any students whose accounts are not fully paid up.

[†]—The church member discount will only be extended to children of members who have been members of the church, in good standing, for a minimum of three years. To be eligible for the discount, the member must celebrate their three-year anniversary prior to the start of the school year (July 1), and remain a member in good standing. In addition, the child(ren) must also be enrolled and actively participating in St. Martin's Lutheran Sunday School and/or Confirmation programs. Active participation is understood to mean that the child(ren) will attend a minimum of 50% of scheduled classes. This waiting period only affects tuition discounts, and has no implication for the enrollment preference otherwise extended to church members.
